# Title: Anti-Human Trafficking & Fugitive Arrests

GARFIELD COUNTY, CO. -

March 7, 2024, and through March 8, 2024, the Garfield County Sheriff's Office worked in close partnership with the Colorado Bureau of Investigation, (CBI), Glenwood Springs Police Department, Rifle Police Department, Basalt Police Department, the 9<sup>th</sup> Judicial District Attorney's Office, the United States Department of Homeland Security/Homeland Security Investigations (HSI), and the Garfield County Special Problem Enforcement and Response, (SPEAR) Team. Together they conducted anti-human trafficking and fugitive location operations throughout Garfield County.

As a result of this operation, ten suspects were taken into custody on a variety of charges and active warrants for their arrests:






Taken into custody on an active warrant for the Sexual Assault of Child and Sexual Assault on a Child by one in a Position of Trust.

Taken into custody on an active warrant for Menacing, Harassment, and Bias Motivated Crimes

Milton Ferdyn Duarte-Garcia, 30 years old of Glenwood Springs and Carbondale



Taken into custody on an active warrant for Vehicular Homicide-Reckless Driving, Criminally Negligent Homicide, Reckless Endangerment, False Reporting, Careless Driving Resulting in Death, and Drove while License Under Restraint for Alcohol related Offense.

In addition to the subjects arrested approximately 4.8 grams of methamphetamine and approximately 2,000 Fentanyl pills were seized. Many of these cases are still under investigation and further charges may result from respective investigations.

The Garfield County Sheriff's Office and our local, state, and federal law enforcement partners remain committed to combating human trafficking and protecting our communities from fugitives from justice.

All subjects are presumed innocent until proven guilty.
